No.SM-51/2017-²⁶²⁸⁰ /R&DM, In the Odisha Mutation Manual, 1962
the following amendments shall be made, namely:-

1. In paragraph-75, for the expression "forty-five days", the expression "thirty days" shall be substituted.
2. After paragraph-83, the following paragraph shall be inserted, namely:-

83A. "The Government shall use electronic devices and requisite software to facilitate speedy disposal of mutation cases, maintenance, updation and correction of Records of Rights (RoR) and map thereof".
