

Sub: Expeditious disposal of applications for issue of Income Certificates in favour of Slum Dwellers.

Madam / Sir,

You are aware of the fact that the State Government have decided that every Landless person occupying land in a slum in any Urban Area shall be entitled for settlement of Land and Certificate of Land Rights shall be issued in accordance with the provisions of the Odisha Land Rights to Slum Dwellers Act, 2017 and Rules framed there under. In this context, the issue of Income Certificate in favour of the prospective beneficiary is relevant for speedy implementation of this flagship programme.

It has come to the notice of Government that in some cases there is delay in disposal of applications for issue of Income Certificates in favour of slum dwellers for which the pace of settlement of land in favour of slum dwellers in urban area has slowed down.

Therefore, Tahasildars / Addl. Tahasildars of urban area under your jurisdiction be instructed to take prompt action for expeditious disposal of applications for issue of Income Certificates in favour of slum dwellers for timely implementation of the flagship programme of Government. The ADMs and Sub-Collectors shall also monitor the actions of Tahasildars / Addl. Tahasildars in this regard.




