## RESOLUTION

RDM-REM-MISC-0017/2014 27029 /R&DM dt 18-8-17-

Sub: Amendment of the Odisha Circuit Houses and Inspection Bungalows Rules, 1985 and Revision of Tariff of Special Circuit Houses & Circuit Houses of the State-regarding.

In partial modification of Revenue & Disaster Management Department Resolution No.37351/R&DM dt.21.08.2012, after careful consideration of the proposal, the Government have been pleased to revise the Tariff rates i.e. User's Charges, Suite Rent, A.C Charges and Cable Charges to the entitled persons, Nonentitled persons and Personal Guests of Entitled persons and Ex.M.P. & Ex.MLA of OLA as per O.C.H & I.B Rules, 1985 under Rule-17(a) (Rule-5&6), Rule-17-b (Rule-7) and Rule-17(e) respectively in the existing Special Circuit Houses & Circuit Houses of the State. This revised Tariff Rate comes into force with effect from the date of issue of this Resolution. The other provisions of Odisha Circuit House & IB Rules, 1985 shall remain unaltered. The details of Tariff Rates of Puri Special Circuit House, all Special Circuit Houses other than Puri and all Circuit Houses in the State have been given below in tabular form:-
