Sub:- Implementation of the scheme "Vasundhara"

Madam/ Sir,

I am directed to say that as you are aware, State Government is attaching utmost priority to allotment of house-sites to all eligible homesteadless families in rural areas of the State under the scheme "Vasundhara". Detailed guidelines have been issued by this Department from time to time for identification of eligible homesteadless families and timely allotment of homestead land to them on a campaign mode.

2. The issue of allotment of homestead land to homesteadless families has also been raised by Hon'ble MLAs on the floor of the Assembly on several occasions either through Assembly Questions or through Calling Attention Notices or otherwise.
3. The Government have made commitment on the floor of the Assembly to provide house-sites to all eligible homesteadless families in rural areas of the State by the end of this Financial Year.
4. As per information available in this Department, near about 25,000 eligible homesteadless families are waiting to get house-site plots throughout the State as on 31st August, 2019.
5. Government desires that all such identified eligible homesteadless families are provided with house-site plots by the end of January, 2020.
6. You are, therefore, requested to fix monthly targets for allotment of land to homesteadless families for each Tahasil so that all the identified eligible homesteadless families are provided with house-site plots by the end of January, 2020 and to ensure that the targets fixed are strictly adhered to by the concerned Tahasildars. You are further advised to ensure that in all cases, correction of record and map is done and there is proper demarcation at the time of delivery of possession.
7. It is also to note that the achievement made in allotment of land to homesteadless families is being reviewed at the highest level of Government every month on a regular basis.

8. Hence, you are requested to furnish each month's achievement to this Department on 1st day of the succeeding month in the Format prescribed below without fail for review by Government. The monthly achievement report should be continued to be submitted to this Department until all identified eligible homesteadless families of the district are provided with homestead land.




