**Sub : Revision of rate of discount and enhancement of sales and purchase of Stamps and stamped papers.**

Sir,

With reference to the subject cited above I am directed to bring your kind attention that Government after careful consideration, have been pleased to revise the rate of discount on purchase of stamp papers as follows:

<b>(B) Hundi Stamps and Impressed Stamps.</b>

3. Exceeding Rs. 500/- but not exceeding Rs.1,000/- each.	2%	3%	-	-

All other rate of discount fixed earlier vide Board of Revenue Notification No. 2909/ Gen. Dt. 31.12.1991 will remain unaltered.

Besides, the ceiling of Rs. 50,000/- fixed for sale & purchase of stamps and stamped papers to the licensed stamp vendors at a time has been enhanced to Rs. 2,00,000/- (Two lakhs). Therefore rule 26 (2) of the Orissa Supply and Sale of Stamps and Stamped Paper Rules, 1990 may be amended accordingly.

This has been concurred in by Finance Department in their UOR No. 331 GSI dtd. 15.5.2008.

Necessary notification in this regard may kindly be issued.
