Sub: Publication of Daily Bulletin on ORTPS.

Madam/Sir,

In inviting your attention to the above mentioned subject, I am directed to say that Government in Revenue and DM Department have issued order vide No. 26161 dated 16.07.2018 to publish a "Daily ORTPS Bulletin" to monitor the disposal of cases by the Designated Officers and the pendency of cases beyond ORTPS time line. Out of 31 (thirty one) public services of Revenue and DM Department notified u/s 3 (1) of the ORTPS Act vide Gazette Notification No. 1668 dated 17.10.2017, 16 (sixteen) services relate to Registration wing.

In order to review the pendency of applications / documents beyond ORTPS time line, you have already been instructed vide this Department Letter No. 23892/R&DM dated 02.07.2018 to enter the information on 16 (sixteen) ORTPS services of each month in the web-based online MPR formats developed by Professional Agency of e-Registration by the 10th of the succeeding month.


For publication of Daily ORTPS Bulletin, information on 11 (eleven) public services shall be fetched from e-Registration application and the information on rest 5 (five) public services as mentioned below shall be entered daily at the end of the day by the Registering Officers and ADM-cum-District Registrars till these services are automated.
