Thirty one (31) services of Revenue and Disaster Management Department are notified as public services under u/s 3 (1) of the ORTPS Act, 2012 vide Gazette Notification No. 1668 dated 17.10.2017.

Government in Revenue and DM Department have issued order vide No. 26161 dated 16.07.2018 to publish a "Daily ORTPS Bulletin" in website of the Department to monitor the disposal of cases by the Designated Officers and the pendency of cases beyond ORTPS time line.

For publication of Daily ORTPS Bulletin, information on issue of miscellaneous & caste certificates and certified copy of RoRs shall be fetched from e-District Application, information on registration services shall be fetched from e-Registration Application, information on uncontested mutation cases shall be fetched from LRMS Application and information on 8-A and 19 (1) (c) cases under OLR Act shall be fetched from RCCMS Application.


