Sub: - Payment of balance 50% of the approved amount to BSNL for 2mbps MPLS connectivity to all Tahsils

Ref: This Department letter No.3716 dated 27.01.2018

Sir,

In inviting a reference to the above mentioned captioned subject, I am directed to say that in 11th GB meeting of OLRMS held on 23.09.2017 under the Chairmanship of Chief Secretary, Government of Odisha an amount of Rs. 5,20,28,754/- had been approved to BSNL for providing 2mbps MPLS connectivity to all Tahasils of the State for one year. It was also agreed that Rs.1,81,00,000/- will be paid out of fund available under DILRMP and balance Rs.3,39,28,754/- will be paid out of interest money of OLRMS. The said amount will be adjusted after getting allotment from Government of India.


In the CTAG meeting held on 16.12.2017 under the Chairmanship of Principal Secretary, Revenue & DM Department the Service Level Agreement (SLA) had been approved and it was decided that to release 50% of the total cost to BSNL for provision of 2mbps MPLS connectivity to all Tahsils immediately. Then 40% of the amount will be paid after providing connection to all 317 Tahsils and rest 10% will be paid after getting SAF from all Tahsildars.

In this context, DLR&S vide his Office letter No. 268 dated 29.01.2018 had made online transfer of 50% of the approved amount i.e. Rs.2,60,14,277/- to BSNL.

In the meantime, BSNL has provided 2mbps MPLS connectivity to all 317 Tahsils of the State and also furnished the Service Acknowledgement Forms (SAF) from all 317 Tahsildars regarding commissioning of 2mbps MPLS connectivity in their respective Tahsils.

You are, therefore, requested to release the rest 50% of approved amount as agreed i.e. Rs.2,60,14,277/- to BSNL after ensuring the progress of work and utilization of earlier amount released to BSNL under intimation to this Department. The bank mandate form for releasing of the payment electronically to BSNL is enclosed herewith.
