





**MINUTES OF THE VIDEO CONFERENCE WITH ADMs AND TAHASILDARS HELD
ON 29.12.2017 AT 3.30 PM UNDER THE CHAIRMANSHIP OF HON'BLE
MINISTER, REVENUE & DISASTER MANAGEMENT**

.....

At the outset, the Principal Secretary welcomed Hon'ble Minister Revenue & DM, all ADMs, all Tahasildars and all Officers of the Department in the Video Conference.

The Hon'ble Minister addressed to all present in the video Conference and inaugurated the Direct Web based information system for Tahasil(DWIST) and Departmental Project Monitoring Unit(PMU) in the Revenue & DM Department.

Initiating discussion, the Principal Secretary asked the ADMs regarding progress of online Mutation in Tahasils of the Districts and achievement on 25 Parameters.

After a threadbare discussion in the Video Conference, the following decisions were taken.

1. The Basic informations on Tahasils will be uploaded through Direct web based information System for the Tahasils (DWIST) by 15.01.2018.
2. Since, 100 Tahasils have already been covered 2 mbps mpls internet connectivity the online mutations have already been started in 30 nos of Tahasil of the state. Similarly, all the Tahasils of the state will be covered 2mbps mpls very shortly and online mutation should be started in all Tahasils within March' 2018.

3. Action taken Report on 25 Parameters is to prepared and submitted to this Department for review in the next ADMs conference scheduled to be held on 20.01.2018.
4. In every third Wednesday of the month, there will be Mutation LokAdalat in all the Tahasils of the State to dispose all long pending mutation cases.
5. All uncontested Mutation Cases will be transferred to the Revenue Inspector for quick disposal.
6. The ADMs should attend all the Mutation Lok Adalat of the Districts from time to time and review the progress of disposal of mutation Cases. All old Mutation Cases should be disposed of latest by ¹⁵⁻⁰²~~31.01.2018~~.
7. Steps should be taken by the ADMs to complete internet connectivity work of all Tahasils in their Districts latest by January 2018.
8. There will be seamless transfer of Grievances from RI office to Tahasil office, Sub-divisional office, District office, Secretariat and vice versa. All e-Abhijogs and CMs Grievances should be disposed of by 31.01.2018.
9. Actions have already been initiated for installation of Helpline/ Toll free Number in the Revenue & DM Department for redressal of grievances on Revenue Matters which will be activated within March'2018 for the benefit of the Public.

The meeting ended with vote of thanks to the chair.
