



No. RDM-CHS-POLICY-0012-2019 29164 / RDM. In exercise of powers conferred under Section 33 of the Odisha Survey and Settlement Act, 1958 (Odisha Act 3 of 1959) the State Government do hereby delegate powers of the Board of Revenue under Sections 6-D, 15 and 25 of Odisha Survey and Settlement Act, 1958 in favour of Sri Nihar Ranjan Dash, OAS(SAG), Addl. Commissioner, Settlement & Consolidation, Cuttack with effect from the date he assumed the charge as such only till posting of a regular officer.

He shall also exercise powers conferred under Clause (h) of Section 2 read with Section 33 of Odisha Consolidation of Holdings and Prevention of Fragmentation of Land Act, 1972.






