NOTIFICATION

Bhubaneswar, dated the 19/10/15

No. 29705/I., RDM., In exercise of the powers conferred by Section 73(C) of the Odisha Land Reforms Act, 1960 (Odisha Act 16 of 1960) and in supersession of the Notification of the Government of Odisha in Revenue Department No.18841/R&DM dated 16.05.2007 the State Government do hereby specify the new industrial units and existing industrial units taking up expansion/ modernization and diversification, the list of which is given in the schedule to the Industrial Policy Resolution, 2015 i.e. exemption of premium on land conversion {Para 5.4.1(e) of IPR 2015} published in the extra-ordinary issue of the Odisha Gazette No.1263 dated 27.8.2015 and direct to be exempted from the application of the provisions of the Odisha land Reforms Act, 1960 particularly from payment of premium leviable under the provisions of Clause C of Section 8(A) of the said act for conversion of agricultural land to any purpose other than agriculture, namely industrial use, subject to production of eligibility certificate from the Director of Industries, Odisha for large Industries and medium enterprises and from General Manager, Regional Industries Centre/ District Industries Centre for Micro & Small Enterprises as follows :

Micro and Small Sector	:	100 % up to 5 Acres
Medium Sector	:	75% up to 25 Acres
Large Sector	:	50% up to 500 Acres
Priority Sector	:	100% up to 5 Acres & 50% for balance areas

Industrial unit that has availed this incentive under any scheme of the State Govt. or the Central Govt. or any Financial Institution(s), it shall be eligible for the differential amount of benefit only.
