Sub : Holding of Camp Courts by Sub-Collectors/Addl. Sub-Collectors at Tahsil level for disposal of Revenue Cases.

Sir,

In inviting reference to the above mentioned subject, I am directed to say that Sub-Collectors/Addl. Sub-Collectors are mandated to dispose of appeal cases under various Revenue Acts and Rules such as OLR Act, 1960, OGLS Act, 1962, OPLE Act, 1962, OEA Act, 1951, Odisha Miscellaneous Certificate Rules, 2017 etc. They also dispose of revenue cases u/s-22, 23 & 23(A) of OLR Act and OPDR Act, 1962 and cases under provisions of Orissa Scheduled Areas Transfer of Immovable Property (by Scheduled Tribes) Regulation, 1956 in respect of scheduled districts of the state.

Delivery of public services to citizens in a hassle free manner within a given time limit is the objective of good governance. Going to sub-divisional headquarters to attend to hearing of cases becomes expensive on part of litigant public and involves avoidable delay. Disposal of cases in camp courts at Tahsil level by Sub-Collectors/Addl. Sub-Collectors can save money and time of the litigant public and will go a long way in expeditious disposal of cases to the convenience of the public.

Government after careful consideration of the above matter have decided that the Sub-Collectors/Addl. Sub-Collectors shall hold camp courts at Tahsil level under their jurisdiction for disposal of all cases. The cases pertaining to a Tahsil under their jurisdiction shall be preferably posted to the camp court to be held at that Tahsil level. They shall hold at least one camp

court per Tahsil in a month so that the number of camp courts held by them in a month shall not be less than the number of Tahsils under their jurisdiction excluding the sub-divisional headquarter Tahsil.

The above instructions shall be followed without fail and deviation on the matter shall be viewed seriously and is liable for action.
