Sub: Engagement of retired Amins for expediting the demarcation of forest land settled under the Forest Rights Act, 2006

Madam/Sir,

I am directed to say that it has been reported by Commissioner-cum-Secretary, ST & SC Development Department that out of 4,21,779 nos. of titles (IFR, CR and CFR titles) distributed under the Forest Rights Act, 2006 in the State as on April, 2018, 1,56,652 nos. of titles are pending for demarcation and 3,20,271 nos. of titles are pending for RoR correction. A district-wise statement in this regard is enclosed for ready reference.

- 2. As stated by the Commissioner-cum- Secretary, ST & SC Development Department, it has been decided in the last Tribes Advisory Council meeting held under the chairmanship of Hon'ble Chief Minister, Odisha on 28/06/2018 to take up the task of demarcation of the remaining forest land vested with the claimants and correction of RoR and Maps with utmost priority.
- 3. Considering the above, Government, after careful direction, have been pleased to direct that demarcation of the forest land vested with the claimants shall be completed within the timeline given below:-

(i)	Districts where less than 1000 demarcation cases are pending	By 31st August, 2018
(ii)	Districts where demarcation cases between 1000 and 10000 are pending	By 30th September, 2018
(iii)	Districts where more than 10000 demarcation cases are pending	By 31st October, 2018

4. It is felt that in order to complete the task of demarcation of all the pending cases within the above stipulated time period, retired Amins have

to be engaged for the particular purpose in those districts where pendency is high i.e. more than 1000 cases since the existing number of Amins may not be sufficient to complete the task within the stipulated period.

5. Keeping the above in view, Government have further been pleased to authorize the Collectors of the following 16 districts, where more than 1000 cases are pending for demarcation, to engage as many retired Amins on contractual basis as would be required to complete the task within the stipulated timeline.

- 6. The aforesaid engagement of retired Amins shall be subject to the following conditions:-
- (i) They shall be paid a consolidated monthly remuneration of Rs.10,000/- (Rupees Ten thousand only).
- (ii) The retired Amins so engaged shall complete demarcation of at least 60 (sixty) cases each month.
- (iii) they shall be paid their monthly remuneration only after completing demarcation of at least 60 demarcation cases in the said month.
- 7. The ST & SC Development Department has been requested separately to place funds required for payment of remuneration to the engaged retired Amins, directly with the concerned Collectors.
- 8. The rest districts which have pendency of less than 1000 demarcation cases shall complete the demarcation work with existing staff or on engagement of retired Amins out of the funds placed by ST&SC Development Department during previous year.

- 9. It is, therefore, requested that necessary action for engagement of required number of retired Amins may kindly be taken immediately and the task of demarcation of all FRA cases pending as on April, 2018 be completed within the stipulated timeline positively.
- 10. Action taken in the matter may be intimated to this Department as well as to ST & SC Development Department.
