In exercise of the powers conferred by clause (a-2) of section 3 of the Odisha Prevention of Land Encroachment Act, 1972 (Odisha Act 6 of 1972) and in supersession of the notification of the Government of Odisha in the Revenue and Disaster Management Department No. 16313-GE (GL)-S-06/2015/R&DM, dated the 1st June, 2015, published in the extraordinary issue of the Odisha Gazette No. 876, dated the 2nd June, 2015, the State Government do hereby specify Rs.60,000/- (Rupees Sixty thousand) only as the ceiling of annual income of homesteadless person as defined in the said clause.


