Consequent upon upgradation of Circuit Houses at Cuttack, Paradeep, Furi, Bhubaneswar, Balasore, Sambalpur, Berhampur and Koraput from 'A' Class to Special Class, 8 posts of Manager in the scale of pay of Rs.5900/- to Rs.9700/- have been created in G.O.No.71635/h., dt.3.12.85 and No.39670/R., dt.5.9.96 for the smooth management of these Special Circuit Houses.

2. It has been decided by Government that 50% posts of Managers of the Special Circuit Houses shall be filled up from amongst the catering supervisors working under three revenue Divisions of the State by way of promotion on seniority-cum-merit basis. The rest 50% posts shall be filled up from amongst the Class-III staff of Revenue Department by way of selection having following experience and qualification.

I. Ten years experience in management of Circuit Houses in the State as Nazir or Asst. Nazir.

Or

II. Five years experience in management of Circuit House and a Diploma in Hotel Management/catering technology/Food Technology or any other equivalent qualification.

3. If it is not possible to get technically qualified persons from the existing grade-III staff working under Revenue Department then the post can be filled up by direct recruitment through advertisement.

4. To regulate the promotion of Catering Supervisors and selection of field staff working under Revenue Deptt.; the posts of Manager of the Special Circuit Houses, a committee is hereby constituted under the Chairmanship of Member, Board of Revenue, Orissa consisting of the following Members.
