Sub: **Visit report of Sri Sangram Keshari Mohapatra, Joint Secretary to Government, Revenue & DM Department to Bhubaneswar Tahasil on 18.01.2018**


Sir,

With reference to the subject cited above, I am to intimate you that on 18.01.2018 Sri Sangram Keshari Mohapatra, Joint Secretary to Government, Revenue & DM Department has visited Bhubaneswar Tahasil. In the tour note of Sri Mohapatra, I found the following actionable points which need your kind attention. These are :-

1. Backlog entry is maximum of 5714 nos. of cases. It requires more 5 nos. of DEOs and more 5 Nos. of computers. Bhubaneswar Tahasil is having at present having 50 Lakh rupees balance as User Fees. Sub-Collector may purchase 5 no. of Computers and engage 5 nos. of DEOs for two to three months for backlog entry from the User Fee.
2. Internet connectivity to be upgraded to 8 mbps.
3. There should be a structured network for at least 25 computers. The LAN is faulty for which bandwidth is choked and therefore suggested Sub-Collector to repair it at once and the expenditure may be met from the User Fee.
4. Training to be imparted on every Saturday at NIC for all Additional Tahasildars and DEOs.
5. 4 Nos. of RI Offices are not having internet connectivity. Sub-Collectors may go for VPN certificate immediately and get internet connectivity from any private ISP/BSNL 699 plan as approved by the R &DM Department in August, 2017.
6. Sub-Collector may instruct to the Tahasildar to have multiple RKs by specifically allotting each village of RI Circle.
7. CCTV camera may be immediately installed and DWIST must be filled up.

You are requested to take necessary steps on these actionable points and report the compliance to this Department within 15 days.
