No RDM-RRC-POLICY-0014-2014/ 34160 R&DM, As per provisions under section 43 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013 (No.30 of 2013) and in exercise of the power conferred by the clause (1) of section 43 of the said Act, the Sub-Collectors working in different districts of Odisha are hereby appointed as Administrator for Rehabilitation and Resettlement in respect of all projects situated in the concerned Sub-Division coming under their jurisdiction and to perform such powers, duties and responsibilities conferred under such provisions of the said Act in addition to their own duties.

However, in such districts where the Project Directors, Rehabilitation and Resettlement have been posted / in position, the concerned Project Directors, Rehabilitation and Resettlement are hereby appointed in place of Sub-Collectors as Administrator for Rehabilitation and Resettlement in respect of all projects situated in the concerned district in addition to their own duties.


