RESOLUTION

RDM-REM-MISC-0024/2018 <sup>34194</sup> /R&DM Dt. 10 SEP 2018

Sub: Charges towards Wi-Fi connection in Special Circuit Houses and Circuit Houses in the State.

In partial modification of R&DM Department Resolution No.27029/R&DM dt.18.08.2017 and after careful consideration, the Government have been pleased to charge an additional amount of Rs.20/- per suite (Both A.C and Non-A.C) in Special Circuit Houses, Puri/ Special Circuit Houses other than Puri and Circuit Houses in the State towards extension of Wi-Fi services. This amount of Rs.20/- will be charged per suite on daily basis in addition to the user charges, suite rent, A.C Charges, Cable Charges and the Wi-Fi Charges will not be deposited in the State Treasury.

The Collector/ ADM will take steps for installation of Wi-Fi in Special Circuit Houses and Circuit Houses by using connection/ service from BSNL or any other Net Provider and this additional amount of Rs.20/- received from the users will be utilised for payment of rent to BSNL or other Net Provider and maintenance charges of Wi-Fi. Separate receipt for the purpose will be issued to the Users/ Guests.

The Collector may utilise a part of the funds placed with them under Demand No-03-2029 for procurement of Furniture & Fixtures vide this Department office letter No.28078 dt.30.07.2018 towards installation of Wi-Fi equipment and incidental expenditure thereof.

This resolution will come to effect from the date of publication in the Odisha Gazette.

**ORDER:-** Ordered that the Resolution will be published in the Odisha Gazette and copy thereof be forwarded to the Principal Accountant General, Odisha, Bhubaneswar/ All Departments of Government/ All Heads of Departments for their information.


