In exercise of the powers conferred by section 51 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) read with rule 3 of the Odisha Land Acquisition, Rehabilitation and Resettlement Authority Rules, 2018, the State Government do hereby establish one Authority to be known as "the Land Acquisition, Rehabilitation and Resettlement Authority" for each Revenue Division for the purpose of providing speedy disposal of disputes relating to land acquisition, compensation, rehabilitation and resettlement and for exercising its jurisdiction for entertaining and deciding the references made to it under section 64 or applications made by the applicant under second proviso to sub-section (1) of section 64.


