No. RDM-Reg-PGMLA-0005-2015 35296 / R&DM, In exercise of the power conferred by sub-section (1) of the section 5 and sub-section (1) of the section 7 of the Registration Act. 1908 (16 of 1908), read with section 6 thereof and in partial modification of the Notification of the Government of Odisha in erstwhile Revenue and Excise Department No. 51675/Regn. dated the 2nd August, 1984, the State Government do hereby direct that the Villages as specified in the schedule below, which have hitherto been included in the local limits of Registration Sub-District of Sohela in the Registration District of Bargarh, as the case may be, shall, with effect from the date of publication of this Notification in the Extra-Ordinary issue of the Odisha Gazette, cease to have been so included and from the said date, the said villages shall form a part of the Registration Sub-District of Bijepur with the Headquarter at Bijepur Tahasil in the Registration District, Bargarh and the State Government also hereby appoint the Tahasildar, Bijepur as ex-officio Sub-Registrar of the Registration Sub-District Bijepur with effect from the said date.
