## ORDER

On the basis of the report of the Commission of Inquiry headed by Hon'ble Justice Shri Bimal Prasad Das, Retired Judge of Orissa High Court for better administration and governance of Shree Jagannath Temple and its endowments and the safety and security of the Temple and the devotees, Government of Odisha have taken up several projects under the Augmentation of Basic Amenities and Development of Heritage and Architecture (ABADHA) Scheme in Puri town. Lands are being acquired/ purchased under the provisions of the RFCTLAR&R Act.

In order to streamline and expedite the process, Government have been pleased to set up a Special Land Acquisition Cell in Collectorate, Puri with following staffing pattern and creation of posts.

- 2. Engagement of retired Government servants may be made as per the guidelines prescribed in GA & PG Department Resolution No.23750/Gen, dated 27<sup>th</sup> August, 2014. Their remuneration may be fixed in consultation with Finance Department.
- 3. The functions/services of data entry operator and support services of Group—D may be outsourced through service providing agencies in a transparent manner as per Finance Department OM No.37323/F, dated 30.11.2018. This will be outsourcing of services/functions not outsourcing of personnel.
- 4. The LA Cell may continue for two years or till completion of Land Acquisition process in Puri under the ABADHA Scheme whichever is earlier.
