In exercise of powers conferred by Section-10(A) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the State Government do hereby exempt the following projects from the application of the provisions of Chapter-II and Chapter-III of the Act.

1. Such projects vital to national security or defence of India and every part thereof, including preparation for defence; or defence production;
2. Rural infrastructure including electrification;
3. Affordable housing and housing for the poor people;
4. Industrial corridors; and
5. Infrastructure and social infrastructure projects including projects under public private partnership where the ownership of land continues to vest with the Government.


