In exercise of the powers conferred by sub-clause(6) of clause-9 of section 2 of the Indian Stamp Act, 1899 (2 of 1899) and in partial modification of the Revenue & Disaster Management Department Notification No.21063/RDM, dated 01.06.2007 and No.43983/R&DM dated 17.10.2008, the State Government do hereby authorize the Sub-Collector, Puri and Additional Sub-Collector, Puri for determination of market value of under valuation cases of Puri sub-division under section 47A of the Indian Stamp Act. The Additional Sub-Collector, Puri will exercise this power in addition to his own duties with immediate effect until further order.
