Sub: Allotment of homestead land to next-of-kin of Central Armed Police Forces (CAPFs) Personnel who die while discharging their duties in anti-Naxalite operation.

Madam/Sir,

I am directed to say that this Department in the G.O No. 8141/R&DM dated 13.03.2015 has communicated the decision of Government that next-of-kin of police personnel of State Government who die while discharging their duties in anti-Naxalite operation shall be allotted government land up to Ac 0.04 in an urban area or Ac. 0.10 in a rural area (except in Bhubaneswar Municipal Corporation) free of premium for homestead purpose under the provision of the Government Grants Act, 1895.

2. Home Department have requested to extend the same benefit to the next-of-kin of CAPF (not only CRPF) personnel belonging to Odisha who die while discharging duties in anti-Naxalite operation anywhere in the country.

3. Now, Government, after careful consideration of the proposal of Home Department, have been pleased to decide that allotment of government land up to Ac. 0.10 in rural area or Ac.0.04 in urban area (except at Bhubaneswar Municipal Corporation) free of premium shall be extended to next-of-kin of Central Armed Forces (CAPFs) Personnel belonging to Odisha who die while discharging their duties in anti-Naxalite operation anywhere in the country.

4. Allotment of land shall be made in favour of the next-of-kin of the deceased CAPF personnel by Government in Revenue & DM Department

only. The concerned Tahasildar shall initiate proposal for allotment of land to such persons under the provisions of the Government Grants Act, 1895 after getting request from such persons and send it to the Collector through the Sub-Collector after proper scrutiny and due recommendation and Collector shall recommend each case to this Department. This Department after getting such proposal from the Collector shall send it to Home Department for concurrence after which allotment of land can be considered on merit by Government in Revenue & DM Department on a case to case basis.

5. All concerned field level revenue functionaries may be informed accordingly.


