### **NOTIFICATION**

No. Regn. 50/08-43983 / R&DM., In exercise of powers conferred by sub clause- (6) of clause-9 of section-2 of the Indian Stamp Act, 1899(2 of 1899) and in partial modification of the Revenue & D.M. Department Notification No.21063/ R&DM dt.01.06.2007, the State Government do hereby authorize the Addl. Sub-Collectors in place of Sub-Collectors of the concerned Sub-Divisions to try under valuation cases under section 47-A of the Indian Stamp Act.

The Sub-Registrar and District Sub-Registrars will refer the cases to the concerned Addl. Sub-Collectors in respect of documents where the consideration or market value set forth in the document is more than Rs.60,000/-(Rupees Sixty Thousand) only and up to Rs.3,00,000/-(Rupees Three Lakh) only for disposal by him where there is vacancy in the post of Deputy Inspector General of Registration and when the post of Deputy Inspector General of Registration is in the office, the Additional sub-Collectors will try under valuation cases where the valuation set forth in the document is above Rs.60,000/- and less than Rs.1,20,000/-.

The Sub-Collectors of the concerned Sub-Division will exercise the powers of Stamp Collectors under section 47-A of Indian Stamp Act, where there is a vacancy in the rank of Addl. Sub-Collectors in the respective Sub-Divisions in the manner specified above.

The Notification No.21063/R&DM dtd.01.06.2007 stands modified to the above extent and all other terms and conditions mentioned in the said Notification stand unaltered.
