Sir,



Ltd. deposited towards establishment and contingency charges for acquisition of Land in seven villages namely; Chemna, Chilida, Jamunaposi, Kodakhaman, Kimirdapasi, Nuagaon Balabhadrapur and Padmakesharpur under Patna Tahasil in the district of Keonjhar.




