Sub: Holding of Camp Courts for disposal of all revenue cases.

Sir,

In inviting reference to the above subject, I am directed to say that the Government have been encouraging innovative practices in governance for improving the delivery of public services. Some Tahsildars are holding camp courts in the villages for speedy disposal of various revenue cases. Instructions have been issued earlier by the Government for holding sufficient number of camp courts for expeditious disposal of revenue cases. For providing public services at the doorstep of citizens and improving service delivery, the Government have been pleased to order as follows.

- (a) The Camp Courts shall be held in all Tahasils of the state either at R.I. headquarters or any other central village on the third Wednesday of every month all over the state without fail .The number of Camp Courts to be held in a Tahasil on this fixed day shall depend on the number of Officers available in the respective Tahasils. All types of revenue cases like mutation ,OLR 8(A), bebandobasta and OPLE etc shall be posted to the camp courts for disposal. The RoRs shall be distributed in the Camp Courts. Disposal of pending mutation cases and cases under 8(A) of OLR Act 1960, shall be accorded topmost priority. If the third Wednesday of the month happens to be a public holiday, the Camp Courts all over the state shall be held on the next working day. The date and time of Camp Courts shall be given wide publicity in the locality in advance.
- (b) Beside the third Wednesday of the month, sufficient number of Camp Courts shall be held by Tahasildars and Add. Tahasildars for expeditious disposal of pending

- revenue cases. There shall be zero tolerance towards of pendency of revenue cases beyond stipulated time as provided under ORTPS Act.2012.
- (c) Despite issue of several instructions for allotment of R.I. circles for disposal of all types of revenue cases by the Add. Tahasildars, it has been brought to the notice of the Government that the instructions are not being carried out in proper letter and spirit. It is reiterated that any deviation from the above instruction shall be viewed seriously.
