

In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamp Act, 1899 (II of 1899), (hereinafter referred to as the said Act) the State Government do hereby remit 40% (Forty percent) of the difference of stamp duty between the duty already paid and what is chargeable on the value of the properties in respect of the following instruments, namely:-

- (i) instruments which have been referred to the Collector under sub-section (1) of section 47-A of the said Act and were pending with the Collector for determination of market value as on the day preceding the date of implementation of Bench Mark Valuation for the first time in the respective district, and have not been disposed of on the date of issue of this order;
- (ii) instruments on which *suo motu* action has been taken by the Collector under sub-section (2-a) of section 47-A of the said Act and were pending with the Collector for determination of market value as on the day preceding the date of implementation of Bench Mark Valuation for the first time in the respective district, and have not been disposed of on the date of issue of this order;
- (iii) instruments which have been registered and pending with the registering officer as on the day preceding the date of implementation of Bench Mark Valuation for the first time in the respective district for referring to the Collector under sub-sections (1) and (2-a) of section 47-A of the said Act for determination of market value.

The above remission will be in force for six months only, from the date of issue of this order.
