RDM-Reg-REGN-0018-2016- 116087. The use of Aadhaar as identifier for delivery of services simplifies the Government delivery processes, brings transparency and efficiency and enables beneficiaries to get their services in a convenient and hassle free manner.

The Odisha Registration Rules, 1988 have been amended incorporating the provision of use of Aadhaar Number (Consent-based) for the purpose of proper identification of the presentants and executants during presenting the document for registration. The said notification has been issued by IGR, Odisha and published in the Odisha Gazette vide No. 1613 dated 06.10.2017.

IGR, Odisha has been appointed as Sub-AUA (Sub-Authentication User Agency) of Odisha Computer Application Centre (OCAC) by UIDAI vide their letter No. K-11022/653/2017-UIDAI (Auth-II)/79-84 dated 13.09.2018 in order to provide Aadhaar Authentication Service during property registration following the provisions of the Aadhaar (Authentication) Regulations, 2016.

The e-Registration Application has been integrated with SRDH (State Resident Data Hub) Aadhaar Authentication Framework of OCAC to enable Aadhaar Authentication of presentants and executants during property registration.

Biometric-based Aadhaar Authentication shall be implemented in all Registration Offices of the State as per provisions of section 57 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 for establishment of identity of presentants and executants during property registration, upon furnishing their Aadhaar Number as per provisions of the Odisha Registration Rules, 1988 as amended vide the Odisha Registration (Amendment) Rules, 2017.

Before collecting the Aadhaar Number of presentants and executants for the purpose of authentication, their consent shall be obtained as per provisions of Section 8(2)(a) of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016.
