## NOTIFICATION

The 26th October 1995

S. R. O. No. 1172/95—In exercise of the powers conferred by clause (a-1) of section 2 of the Orissa Scheduled Areas Transfer of Immovable Property (by Scheduled Tribes) Regulation, 1956 (Orissa Regulation 2 of 1956) the State Government do hereby appoint the Officers specified in column (3) of the Schedule given below to perform the functions of a competent authority under the said Regulation within the Scheduled Areas located in different districts as specified against each in column (4) thereof.
