**Sub: Creation of 03 (three) posts of Senior Clerk, 06 (six) post of Junior Clerk and 03 (three) posts of Junior Stenographer in three RDC Offices for their posting in the Office of Land Acquisition, Rehabilitation and Resettlement Authority.**


Sir,

I am directed to convey the sanction of the Governor to the creation of the following posts in the office of Land Acquisition, Rehabilitation and Resettlement Authority as per details below:

1. Senior Clerk (03 posts) - One post each in three RDC offices with the pre-revised scale of pay Rs. 9,300-34,800, G.P. of Rs. 4,200/-, corresponding to level 9 of ORSP, 2017 with usual D.A. and Other Allowances as sanctioned by Government from time to time.
2. Junior Clerk (06 posts) - Two posts each in three RDC offices with the pre-revised scale of pay Rs.5,200-20,200 with G.P of Rs. 1900/-, corresponding to level 4 of ORSP, 2017 with usual D.A. and Other Allowances as sanctioned by Government from time to time.
3. Junior Stenographer (03 posts) - One post each in three RDC offices with the pre-revised scale of pay Rs.5,200-20,200 with G.P. of Rs. 2400/-, corresponding to level 7 of ORSP, 2017 with usual D.A. and Other Allowances as sanctioned by Government from time to time.
4. The above posts shall be filled up following Government norms and procedures.
5. The charges to the above 03 posts is debitable to the Head of Account under "Demand No. 03-R&DM Department-EO&M Expenditure-2053-00-101-Commissioners-1209-Revenue Divisional Commissioners-Office Establishment" in the B.E for the year 2019-20.


