**Sub: Institution and disposal of cases u/s 19(1) (C) of O.L.R.Act,1960 during the current year 2004-05 as on December, 2004.**

Sir/ Madam,

Kindly refer to this Department letter No.16002/R., dt.25.3.2003 and No.1390 dt.9.1.2004 and No.39516 dt.8.10.04 on the above noted subject and to say that even though a target has been given to each R.I. to institute 10 cases u/s 19(1) (C) of O.L.R. Act in each month, no tangible action appears to have been taken at the district level to follow the instructions of Government. Wide publicity for institution and disposal of cases under this section made through press note vide this Department letter No.32460 dt.25.6.03 has not also yielded much result.

It is seen from the M.P.Rs. for the current year that only the District Collectors of Kendrapada, Jajpur, Puri, Mayurbhanj, Koraput, Nabarangpur, Ganjam, Bolangir, Jharsuguda and Sundargarh have furnished M.P.Rs. regularly to this Department in pursuance to the Government instructions issued in this regard from time to time. The District Collectors of Nayagarh, Rayagada, Nuapada and Dhenkanal have furnished M.P.Rs. irregularly to this Department. This shows that these Districts have not given much importance to the Government instructions. It is noticed from the M.P.Rs. of the above Districts that the Tehsilwise performance is not at all satisfactory. The performance of each District is described in the Statement (Annexure-A).

The district Collectors of Balasore, Bhadrak, Cuttack, Jagatsinghpur, Khurda, Angul, Deogarh, Sambalpur, Bargarh, Kalahandi, Subarnapur, Boudh, Kandhamal, Gajapati, Keonjhar and Malkangiri have not furnished M.P.Rs. to this Department. It implies that these District Collectors have not reviewed the performance during the current year as per the instructions of Revenue Department.

You are, therefore, requested to kindly review the matter regularly and instruct the Tehsildars to see that atleast 10(ten) cases u/s 19(1) (C) of O.L.R.Act in each month are instituted by each R.I. In case of defaulting Tehsildars/ R.Is., action should be taken against them for non-adherence to Government instructions. Steps should also be taken to dispose of the pending cases instituted so far and monthly Tehsilwise/ R.I.wise review report submitted to L.R.C./ Government immediately. Any hurdles faced by the Tehsildars/ R.Is. in the matter alongwith your suggestions to overcome the same may please be intimated to this Department.
