Amendement to the instructions issued in this Department letter No. 52412 dt. 13.10.99 regarding issue of licence for temporary use of Government land for holding Mela, Exhibition, Festivals, Circus, Meetings and for putting up temporary shop and stalls for sale of seasonal articles.

Sir,

I am directed to invite reference to your aforesaid letter on the subject cited above and to say that after careful consideration of the proposals contained in your letter under reference, Government have been pleased to amend the instructions contained in this Department letter No. 52412 dt. 13.10.99 referred to above as follows:

Licence Fee

Vide Para - 3 (A) of the instructions:

The rates of licence fee for Berhampur, Cuttack, Sambalpur & Rourkella urban areas, both for the purpose of Mela etc. and for putting up shops, were fixed at par with the rate of daily ground rent adopted for similar purposes for Bhubaneswar area by the G.A. Department. As such it will not be expedient to fix a higher rate of fees than that applicable in case of Bhubaneswar for similar purposes. However, Government have been pleased to amend item - A of Para - 3 of the instructions as follows which would substitute the existing provisions under the said item-A of Para - 3 i.e. Licence Fees.

PURPOSE

For Melas, Festivals, Circus, Yani-Yatra, Exhibitions and Meetings:

- (a) In respect of Berhampur, Cuttack, Sambalpur and Rourkela urban areas
- (b) Other town and urban areas excepting those mentioned in (a) above and Bhubaneswar and Sunabeda.

LICENCE FEE PER DAY

Minimum of Rs. 100 (Rupees one hundred only) up to one acre and Rs. 10/- (Rupees ten only) for each additional 10 decimal or part theirof per day.

Minimum of Rs. 75/- (Rupees seventy five) only up to one acre and Rs. 7.50/- (Rupees seven and paise fifty) for each additional 10 decimal or part theirof per day.

(c) Rural areas.

Minimum of Rs. 50/- (Rupees fifty only) up to one acre and Rs. 5/- (Rupees five only) for each additional 10 dec. or part theirof per day.

- II. Setting up of temporary Stalls/ shops including roadside shops and stalls on specific festive occassions for sale of materials:-
- (a) In respect of Berhampur, Cuttack, Sambalpur and Rourkela urban areas

Minimum of Rs. 40/- (Rupees forty only) up to 100 sq. ft. and Rs. 4/- (Rupees four only) for each additional 10 sq. ft. or part theirof per day.

(b) Other town and urban areas excepting those mentioned in (a) above and Bhubaneswar and Sunabeda. Minimum of Rs. 30/- (Rupees thirty)only up to 100 sq. ft. and Rs. 3/- (Rupees three only) for for each additional 10 sq. ft. or part theirof per day.

(c) Rural areas.

Minimum of Rs. 20/- (Rupees twenty only) up to 100 sq. ft. and Rs. 2/- (Rupees two only) for for each additional 10 sq. ft. or part theirof per day.

2. Authority competent to grant Licence :

The existing paragraph - 5 (i) of the instructions i.e. authority competent to grant licence will be substituted as follows:—

Authority competent to grant licence.

- In respect of district headquarters towns Collector of the district will be competent to grant such licences. In respect of other towns and urban areas (excepting Bhubaneswar and Sunabeda) the Sub-Collector of the area will grant such licences whereas for rural areas the Tahasildar concerned will be competent to grant this licence.
- Appeals:
 After Paragraph 5 (ii) and before Paragraph 6 of the instructions the following new paragraph will be inserted:

Apeals 5-A Against the orders of Tahasildar appeal may be filed before the Sub-Collector having jurisdiction over the area and against the orders of the Sub-Collector appeal may be filed before the Collector of the district. Similarly, against the orders of the Collector appeal may be filed before the Revenue Divisional Commissioner of the division concerned. Such appeal should be filed within a period of 15 days from the date of the original order passed by he authority concerned.

These amendments will come into force with immediate effect. Receipt of the letter may kindly be acknowledged.
