In exercise of the powers conferred by column (3) against serial number 7 of the Second Schedule read with section 31 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013(30 of 2013), the State Government do hereby specify that the one-time financial assistance, for each affected family having cattle or having a petty shop, shall be twenty-five thousand rupees for construction of cattle shed or petty shop, as the case may be.






