The following draft of certain rules to amend the Odisha Survey and Settlement Rules, 1962, which the State Government propose to make in exercise of the powers conferred by sub-section (2) of section 43 of the Odisha Survey and Settlement Act, 1958 (Odisha Act 3 of 1959) is hereby published as required under sub-section (1) of the said section for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration on or after the expiry of thirty days from the date of publication of this notification in the Odisha Gazette;

Any objection or suggestion which may be received from any person with respect to the said draft before expiry of the period so specified will be considered by the State Government.

Draft

1. (1) These rules may be called the Odisha Survey and Settlement (Amendment) Rules, 2020
- (2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Survey and Settlement Rules, 1962 (hereinafter referred to as the said rules), in rule 40, the following provisio shall be inserted, namely : -

"Provided that when all co-sharers or recorded tenants sell the plot part or in full, such notice shall not be required to be issued."

3. In the said rules, in rule 41, the following provisio shall be inserted, namely: -

"Provided that when all co-sharers or, recorded tenant(s) sell the plot part or in full, the mutation application shall be disposed of without hearing of the parties and [further] without holding the field enquiry, so that disposal of such mutation case is ensured within a week."

4. In the said rules, in rule 42, for sub-rule(2), the following sub-rule shall be substituted, namely: -

(2) *"Every such appeal shall be presented within 180 (one hundred eighty) days from the date of order appealed against :*

Provided that the appeal period shall not be a bar for correction of records in respect of mutation case, where all co-sharers or recorded tenants sell the plot part or in full.
