**Sub: Alienation of government land in favour of SSEPD Department for setting up Integrated Infrastructure Complex (IIC) for rehabilitation of PwDs, drug addicts, older persons, transgenders etc.**

Madam/ Sir,


With reference to the subject noted above, I am directed to say that Principal Secretary to Government, Department of Social Security & Empowerment of Persons with Disabilities (SSEPD Department) vide his letter No. 5223/SSEPD dated 29/07/2016 has requested all Collectors to identify a patch of 25 acres of government land in each district and alienate the same in favour of the Department for setting up Integrated Infrastructure Complex for rehabilitation of Persons with Disabilities, drug addicts, older persons, transgenders etc. As stated by him, the Integrated Complex will consist of one Old age Home, one District Disabilities Rehabilitation Centre, one Drug De-addiction Centre, one Home for Mentally ill, facilities for socio- vocational rehabilitation of transgenders which will provide necessary infrastructural support for rescue, care, protection, skilling and rehabilitation of these vulnerable sections of the society.

2. The SSEPD Department vide the aforesaid letter has also authorized the District Social Security Officer to submit the alienation proposal to the competent revenue authority.

3. As you are aware, the State Government is attaching utmost priority for the welfare and development of these neglected segments of the population. There are also Central Acts that mandate undertaking welfare measures for these segments of the society.



In this context, you are requested to take appropriate steps to identify suitable government land measuring about 25 acres preferably close to the District Headquarters for the purpose in consultation with the District Social Security Officer and also to take necessary steps at the earliest for alienation of the land so identified in favour of SSEPD Department soon after receipt of requisition from the authorized officer.




