NOTIFICATION

In pursuance of Clause (3-a) of Section 2 of the Odisha Land Reforms Act, 1960 (Odisha Act 16 of 1960), the State Government do hereby appoint all Sub-Collectors as Authorized Officers under the provisions of Section 8-A of the said Act in their respective Sub-Division Headquarter Tahasils for conversion of land measuring one-fourth of an Acre or more than that. In these cases, the Tahasildar concerned shall initiate the OLR Case for the purpose and allow conversion with due approval of the Sub-Collector.

For the area measuring less than one-fourth of an Acre in the Sub-Division Headquarter Tahasils, the respective Tahasildars will continue to be the Authorized Officers for conversion under the provisions of the OLR Act, 1960 except where the local Development Authority has given permission for conversion with reference to section 119(3) of the ODA Act as amended in the year 2015.

No.1175/95, Dated 25<sup>th</sup> October, 1995 of the Revenue and Excise Department, published in the Orissa Gazette No.1301, dated 18.11.1995 is hereby modified to the above extent.


