

Project :- Widening Of Road By 30 Feet Around

Shree Jagannath Temple For Nabakalebar2015 Rs.16,50,000

Acquired Area- Ac. 0. 168-5

This is regarding preparation of draft Rehabilitation & Resettlement Scheme under the land acquisition for widening of Road by another 30 feet around Lord Jagannath Temple for Nabakalebar-2015.

In this case notification u/s 11(D) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act -2013 and ordinance of 2014 bearing No.673 dt.08.01.15 has been issued by Govt. in R & DM Deptt. published in locality by beat of drum on 09.01.15 for information of public inviting objections for hearing by Collector on 10.3.15 . Objections were heard in L.A. Case No. 4/2015 for Mouza- Baselisahi and disposed .The orders of Collector are placed in case record.

Then u/s 16 a survey was conducted to under take a census of affected families which included (1) particulars of land and immovable properties being acquired (2) loss of livelihood (3) Rehabilitation and Resettlement amount payable to affected families. The hearing was conducted by Administrator on 10.03.2015. While preparing the Draft for Rehabilitation and Resettlement Scheme following guiding principles were followed.

1. There is no proposal for Resettlement as no household is being displaced.
2. One time grant of Rs.25,000/- may be provided to small traders or self employed persons of adversely affected families whose livelihood disturbed due to Land Acquisition Process in Baselisahi mouza.
3. The Land owners/House owners who were getting rents may also be provided with one time grant of Rs.25,000/- per shops given on rent.
4. As the shop keeper who were losing their shop rooms were lessees will be provided with space for shops.

Summary of plan

1. Total nos. of shops - 33
2. Amount of allowance proposed be paid to adversely affected families (Business men) as per survey list attached.
 $33 \times 25000 = 8,25,000 /-$ (One time grant)
3. Equal Amount of allowance proposed be paid House owners
 $33 \times 25000 = 8,25,000 /-$ (One time grant)
4. Total amount proposed to be paid to affected families = Rs.16,50,000/-
