Sub: Regarding updation of Electronic Tenant Ledger(ETL)

Ref: This Department Letter No. 27658 dated 18/09/2020

Madam/ Sir,

I am to say that detailed guidelines have been issued from Government vide above-referred letter for online payment of land revenue and complete realisation of land revenue by online mode in future. In fact, a series of letters have been marked for updation of ETL and SoP for updation of ETL by RIs was made available in the e-pauti portal.

Now, it has come to notice that R.I.s are facing difficulties while updating ETL in respect of Government khatas, *Chhut* khatas, bebandobasta and FRA khatas. *Chhut* khatas are those khatas from which the land has been completely transferred to other khata(s) earlier. Similarly, in Bebandobasta khatas, the land revenue has not been assessed. In Government and FRA khatas, the land revenue is not fixed. Hence, there is



no requirement to make entry of demands in respect of all these Khatas in ETL.

You would further appreciate that despite several instructions issued for 100% updation, till date, ETL has not been updated fully by Revenue Inspectors thereby causing difficulties for citizens in making online payment of the land revenue.

Hence, you are impressed upon to instruct your field officials to update ETL 100% excluding the Government khatas, Chhut khatas, bebandobasta khatas and FRA khatas positively by 31/01/2020.
