
In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw **Ac.2.86 dec.** of land out of **Ac. 18.65 dec** of land as per the land schedule given below in village-Jiani , P.S-Koliana No. 242, Tahasil- Koliana, District- Mayurbhanj covered by Revenue & DM Department Notification No. 20986 dated 11.07.2016 published in the extraordinary issue of the Odisha Gazette No.1272 dated 22.07.2016 and Declaration No. 2013 dated 18.01.2017 published in the extraordinary issue of the Odisha Gazette No.124 dated 25.01.2017, acquired for construction of Jhanjadapal & Jiani Sub Minor and Palbani Minor of Haladia Left Canal under Subarnarekha Irrigation Project of which possession has not been taken.
