
Sub: Revision of market value of immovable properties.

Madam/Sir,

In continuation to this Department letter No.26164/R&DM, dated 02.09.2020 on the above cited subject, I am directed to say that in order to give relief to the registrant public during the economic crisis arising out of extraordinary situation of COVID-19 pandemic, the market values of immovable properties of all districts (except Khordha and Bargarh) of the previous financial year (2019-2020) as on 31st March, 2020 shall remain in force till the end of current financial year (2020-2021), i.e., 31st March, 2021.

Further, the market values of immovable properties of Khordha and Bargarh districts have been enhanced by 10% w.e.f. 01.04.2020 and 13.05.2020, respectively. In these two districts, the pre-revised rate of market value of immovable properties, i.e., the rate as on 31st March, 2020 shall be applicable prospectively from the date of issue of this letter till 31<sup>st</sup> March, 2021.


Therefore, you are, requested to take appropriate action on the matter immediately.
