Sub: Revision of market value of immovable properties.

Madam/Sir,

In continuation to this Department letter No.26164/R&DM, dated 02.09.2020 on the above cited subject, I am directed to say that in order to give relief to the registrant public during the economic crisis arising out of extraordinary situation of COVID-19 pandemic, the market values of immovable properties of all districts (except Khordha and Bargarh) of the previous financial year (2019-2020) as on 31st March, 2020 shall remain in force till the end of current financial year (2020-2021), i.e., 31st March, 2021.

Further, the market values of immovable properties of Khordha and Bargarh districts have been enhanced by 10% w.e.f. 01.04.2020 and 13.05.2020, respectively. In these two districts, the pre-revised rate of market value of immovable properties, i.e., the rate as on 31st March, 2020 shall be applicable prospectively from the date of issue of this letter till 31st March, 2021.

Therefore, you are, requested to take appropriate action on the matter immediately.
