No RDM-LAA-MBJ-0018-2017/ 6525 R&DM, dated 23 FEB 2019


In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw Ha.1.1770 of land out of Ha 3.2870 of land as per the land schedule given below in village-Garudabasa , P.S- Betnoti No. 95, Tahasil- Betnoti, District- Mayurbhanj covered by Revenue & DM Department Notification No. 8762 dated 16.03.2017 published in the extraordinary issue of the Odisha Gazette No.753 dated 21.04.2017 acquired for construction of Nuagaon Distributary under Subarnarekha Irrigation Project of which possession has not been taken.
