
Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of Ac 8.44 in village–Niunti, P.S. Karanjia-68, under Karanjia Tahasil of Mayurbhanja District vide Revenue and DM Department notification No. 38264 dated 10.10.2018 which was published in the Extraordinary issue of Odisha Gazette on dated 04.01.2019 and declaration under section 19(1) of the Act in respect of the above schedule of land has not been issued till date;

And whereas, in consideration of the request of DoWR with justification, the validity period was extended up to 31.03.2020 for issue of Declaration under section 19(1) of the said Act vide Revenue and DM Department notification No. 2167 dated 13.01.2020;

And whereas, in view of the pandemic arising out of COVID-19, frequent Lockdown & Shutdown have been declared by Government to prevent spread of the pandemic, for which the appropriate Government is of the opinion that the circumstances exist justifying the same;

Now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to extend the period of twelve months from the date of Preliminary Notification U/s 11(1) of the R&DM Act, 2013 up to **31st December 2020** for issue of Declaration under section 19(1) of the said Act.
