
ADDITIONAL PROPOSAL TO REHABILITATION AND RESETTLEMENT POLICY FOR IMPROVEMENT OF ROAD ON BOTH LEFT AND RIGHT EMBANKMENT OF TALADANDA CANAL FROM RANIHAT CHAAK UPTO BIRIBATI ISSUED VIDE LETTER NO.37700/R&DM, DT.23/12/2020

- 1. Commercial Establishments of CMC or any other Govt institutions :** One time assistance at the rate of Rs. 1,00,000/- per shop/ Commercial establishments paid only to the Registered shop owner and his/her security deposits shall be released by the respective offices as per existing terms and conditions. Further the affected venders shall be given priority in allotment of vending zones in CMC.


It is decided to recommend the addition to R&R package intimated vide Letter No-37700/R&DM, Dated 23.12.2020 to the Govt in proper quarter for necessary approval for further course of action.
