

In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw Ac.2.92 dec. of land out of Ac. 7.05 dec of land as per the land schedule attached herewith in village-Chitrada , P.S-Morada No. 49, Tahasil- Morada, District- Mayurbhanj covered by Revenue & DM Department Notification No. 7155 dated 03.03.2017 and Declaration No. 34780 dated 21.10.2017 published in the extraordinary issue of the Odisha Gazette No.544 dated 25.03.2017 and No.2032 dated 24.11.2017 respectively acquired for construction of Baisinga Branch Canal under Subarnarekha Irrigation Project of which possession has not been taken.






