In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to amend the Odisha Higher Secondary Education Service (Method of Recruitment and Conditions of Service of Post Graduate Teachers of the School and Mass Education Department) Rules, 2018, namely: -

- 1. Short title and Commencement.-(1) These rules may be called the Odisha Higher Secondary Education Service (Method of Recruitment and Conditions of Service of Post Graduate Teachers of the School and Mass Education Department) Amendment Rules, 2021.
- (2) They shall come into force on the date of their publication in the Odisha Gazette.
- 2. In the Odisha Higher Secondary Education Service (Method of Recruitment and Conditions of Service of Post Graduate Teachers of the School and Mass Education Department) Rules, 2018, in rule 6, in sub-rule(1) of para- 'A':-
- (a) for clause (J), the following clause shall be substituted, namely:-
- "() have Master's Degree in subject concerned from a recognised University with at least 50% marks in aggregate and have possessed two years Post Graduate Master's Course or integrated six years Post Graduate Master's Course from Regional College of Education recognised by the NCERT in the concerned subject with minimum 50% marks in aggregate."
- (b) after clause(k), the following proviso and the Explanation shall be inserted, namely:-

"Provided that B.Ed. qualification shall not be the mandatory eligibility criteria for the post of PGT in the subjects where B.Ed. Course is not offered.

Explanation: For removal of doubt, it is hereby clarified that these rules does not confer any right for appointment of departmental candidates having M.Phil or Ph.D and B.Ed. as PGT in Higher Secondary Schools."
