
Whereas the preliminary notification under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by Government for acquisition of private land measuring an area of Ac 11.70 in village—Ankura, P.S. Karanjia-66, under Karanjia Tahasil of Mayurbhanja District for construction of Baliposi Minor, Sanadiha Sub-Minor and Niunti Sub Minor of Deo Irrigation Project vide Revenue and DM Department Notification No. 39624 dated 25.10.2018 which was published in the Extraordinary Issue of Odisha Gazette on dated 09.01.2019 and declaration under section 19(1) of the Act in respect of the above schedule of land has not been issued till date;

And whereas, in consideration of the request of DoWR with justification, the validity period was extended up to 31.05.2021 for issue of Declaration under section 19(1) of the said Act vide Revenue and DM Department notification No. 10888 dated 30.03.2021;

And whereas, in view of the situation arising out of COVID-19 pandemic and the Water Resources Department has again requested with reasons to extend the period of twelve months and the appropriate Government is of the opinion that circumstances existed for the inadvertent delay;

Now, therefore, in exercise of the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the State Government do hereby decide to extend the period of twelve months from the date of Preliminary Notification U/s 11(1) of the RFCTLAR&R Act, 2013 up to **31st August 2021** for issue of Declaration under section 19(1) of the said Act.
