In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw an area of Ac. 0.67 out of the notified area of Ac.0.92 as per the land schedule given below in village-**Bishnupur**, P.S.- Baisinga No.9/1, Tahasil- Betnoti, Dist- Mayurbhanj covered by Revenue & DM Department Notification No. 15482 dated 29.05.2019 published in the extraordinary issue of the Odisha Gazette No.1348 dated 26.07.2019 and Declaration No.11406 dtd 07.03.2020 acquired for construction of Baisinga Branch canal under Subarnarekha Irrigation project of which possession has not been taken.
