



WITHDRAWAL NOTIFICATION

No RDM-LAA-MBJ-0051-2019 3933 /R&DM, dated 4 FEB 2021

In exercise of the powers conferred by Section 93 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013, the State Government do hereby withdraw an area of Ac. 0.35 out of the notified area of Ac.16.85 as per the land schedule given below in village-**Kesharipur**, P.S.- Baisinga No.8, Tahasil- Betnoti, Dist- Mayurbhanj covered by Revenue & DM Department Notification No. 23198 dated 09.08.2019 published in the extraordinary issue of the Odisha Gazette No.1706 dated 05.09.2019 and Declaration No.27885 dtd 22.09.2020 acquired for construction of Baisinga Branch canal and Muktapur Minor under Subarnarekha Irrigation project of which possession has not been taken.
